TERMS AND CONDITIONS

Unless otherwise stated, the Customer and the Manufacturer agree as follows:

1. The Customer shall take delivery of the camper trailer from the Manufacturer’s premises within seven (7) days of the Manufacturer advising the Customer that the camper trailer is available for delivery.
2. If a trade-in has been accepted, before taking the camper trailer the Customer shall deliver to the Manufacturer the Trade-in camper trailer together with all accessories, extra’s and attachments fitted at the time of valuation. If the Trade-in trade-in item is not in substantially the same condition as when valued by the Manufacturer, the Manufacturer and the Customer may negotiate a variation to the nett Trade-in allowance or either party may rescind the contract.
3. At or before delivery the Customer shall pay the Manufacturer the balance of the purchase price shown as “Balance Payable” on the front section of this Contract under Section C. Payment must be made by: Cash, Bank Cheque or Direct Deposit into our nominated bank account. A copy of the deposit slip must be sent immediately to the Manufacturer. If the camper trailer is financed by a credit institution it is the customers responsibility to ensure the funds have been deposited into the Manufacturers account or a Bank Cheque is issued to the Manufacturer prior to delivery of the new camper trailer.
- 3.1 The Purchase price and the “Balance Payable” may be varied if, before the delivery of the camper trailer there is a change in the Manufacturers procurement price, exchange rate, statutory charges or applicable taxes and duties. The Manufacturer shall inform the Customer of any variation in the purchase price.
4. If the camper trailer is delivered to the Customer by a dealer, the same payment terms as from 3. apply.
5. Where the Customer refuses or fails to take delivery of the camper trailer within 30 days, the Manufacturer may terminate the Contract by written notice to the Customer. There after any deposit paid or payable by the Customer to an amount not exceeding 15% of the total purchase price of the camper trailer shall be forfeited to the Manufacturer.
6. Where the Customer advises the Manufacturer prior to entering into this contract that he/she requires credit to be provided for payment of the camper trailer and having taken reasonable steps has been unable to obtain credit, the Customer may within a reasonable period by notice in writing given to the Manufacturer to rescind this Contract.
7. Where this contract is lawfully rescinded, the Manufacturer shall refund any monies paid by the Customer and where possible return any trade-in items PROVIDED THAT the Manufacturer shall retain from any monies due to the Customer the actual cost of repairs and improvements made to the trade-in item.
8. If provisions of any Federal or State Law apply to this Contract those provisions are deemed to be incorporated into the Contract and the Customer shall have the full benefit thereof, but only to the extent to which those warranties are applicable to the Contract and may not be excluded therefrom. All warranties are expressly negated and excluded.
9. Any addition to or variation of these terms and conditions will have no effect unless made in writing and signed by the parties to this contract.
10. The Manufacturer shall use his best endeavours to acquire the camper trailer by the estimated delivery date, but shall not be liable to the customer for any damage or loss whatsoever arising either directly or indirectly from any such delay or failure of delivery.
11. If the Manufacturer has not delivered the camper trailer to the Customer within thirty (30) days of the estimated delivery date, the Customer may by notice in writing to the Manufacturer rescind the Contract.
12. Both the Manufacturer and the Customer acknowledge that the camper trailer is of unusual design or combines unusual options and that the customer waives his right to rescission as provided in clause 11.
13. Small variations from camper trailer to camper trailer can occur particularly in fibreglass, powder coating or other materials or components, especially those outside of the direct control of the manufacturer. The manufacturer will not accept warranty claims that are the result of such variations or to minor imperfections in finishes.
14. The Customer has agreed to enter into this contract knowing that this camper trailer is individually built and that there are variances from the camper trailer on which the purchase decision was made. Furthermore the Customer acknowledges that he is aware that no two camper trailers are identical in terms of final finish.
